In 2011 and 2012, Charlie served in the executive branch of Florida state government as the General Counsel to the Executive Office of Governor Rick Scott. There he was responsible for advising the Governor and his agency on a variety of complex and difficult legal issues. He also served as the chief ethics officer of the Governor's agency. He returned to private practice in 2012.

Between 2017 and 2019, Charlie returned to public service as Chief Counsel for the Federal Aviation Administration in Washington, D.C. There he served as legal advisor to the FAA Administrator and FAA leadership, and managed the legal and administrative staff of the FAA's Office of the Chief Counsel, under the guidance of the Office of the General Counsel of the U.S. Department of Transportation. At the FAA, he oversaw a staff of approximately 180 attorneys, dealing with all aspects of the FAA's mission of aviation safety and its provision of air traffic control services, including unmanned aircraft systems, new air traffic control procedures and technologies, and commercial space launch and reentry.

In June 2019, Charlie again returned to private practice in Florida, this time with Abel Bean Law.
